Compliance declaration REACH, CLP, RoHS3, ELV, WEEE, POP

The copper and copper alloy products supplied by Aurubis Finland do not contain Substances of Very High Concern (SVHC) on the ECHA Candidate list of substances for authorization (233 substances as of January 17th, 2023) and RoHS list, above relevant threshold values.

The products do not contain organic substances nor halogens.
